The organization trained almost 300 young musicians in its three orchestras Internationally acclaimed guest artists joined our young musicians in concert, sharing their performance skills and also offering workshops and master classes to our students The organization offers complimentary concert access to the community at large The 2013-2014 season included five blockbuster performances, among them a side-by-side concert with the local professional orchestra, the Fresno Philharmonic, and a performance of the Beethoven Ninth Symphony with full chorus and internationally acclaimed soloists The Youth Orchestras also cohosted the International Cello Festival at CSU Fresno

Our FOOSA (Fresno Opera & Orchestra Summer Academy), String Edition 2014, brought together world-class faculty members and international students to work with our local young musicians in an intensive two-week training session to create a 90-piece orchestra An additional 50 students participated in the half-day program for less advanced studies The FOOSA Orchestra toured to Los Angeles, CA to perform at the Walt Disney Concert Hall Concerts in Los Angeles and Fresno brought in about 1,500 audience members FOOSA emphasized its high-caliber faculty, which included violinists Lorenz Gamma and Dr Limor Toren-Immerman, cellists Dr Thomas Loewenheim and Thomas Landschoot, double bassist Bruce Bransby, and pianist Hatem Nadim
