4a (Code:) (Expenses \$ 153720 including grants of \$ 980) (Revenue \$ 215722)
Overture Band Programs provided band programs to 18 private, parochial and home schools in Dane County, WI, that would otherwise be unable to offer and provide instrumental music education to their students. Five hundred-one (501) students from those 18 schools participated in Overture's band programs for the 2013-14 school year. Overture Band Programs had three full-time employees and three part-time employees to provide these services. Fourteen families from nine schools received a combined total of \$980 in tuition assistance from Overture Band Programs. Overture was contacted by a school, not currently using Overture's services, to provide a band program for their 4th and 5th grade students for the 2014-15 school year
Music instruction provides students with academic and aesthetic experiences that enhance and enrich the quality of their comprehensive education and their lives, and serves as an avenue for creativity, self-awareness and self-expression. Music education also increases a student's self-confidence and positively influences the development of higher cognitive processes and enhances one's spatial intelligence.

4b (Code:) (Expenses \$ 5828 including grants of \$ 0) (Revenue \$ 5455)
Overture Band Programs offers two summer opportunities for participating students to extend their instrumental music education through the summer months. Through more individualized instructions, 26 students from 5 participating schools received 1/2-hour private lessons from an Overture instructor (employee) for five weeks during the summer. Three of Overture's employees were instructors for this program.
The other summer opportunity offered to participating students is a one-week band camp. Students who participate in Summer Band Camp meet for 3 1/2 hours each day for five days. Their schedule includes a daily assembly, two group band rehearsals, two music related classes, and the opportunity to learn to play a different instrument for the week. The week concludes with a performance for parents and friends, showcasing what the students learned throughout the week. Twenty-seven (27) students from 10 schools participated in Overture's Summer Band Camp in June 2013. Four of Overture's employees were instructors for this program

4c (Code:) (Expenses \$ 5261 including grants of \$ 0) (Revenue \$ 3617)
Overture Band Programs offers its more advanced students the opportunity to participate in Overture's Honor Band, Jazz Band, and in the Wisconsin School Music Association's Solo & Ensemble Festival. Fifty-six (56) students from 13 schools participated in the WSMA District Solo & Ensemble Festival in February 2013, where they had prepared 63 solos and 3 ensembles and performed them for an adjudicator. Students received a rating and comments regarding their performance from the adjudicator. Participation in Solo and Ensemble Festival teaches students to hone their musical skills and to reach a higher level of performance. It also helps students gain poise and self-confidence. Two students from one school advanced to the state level.
Honor Band and Jazz Band provide the students that participate the opportunity to expand their music repertoire, play music that is more challenging (both musically and technically), have a larger group band experience, and perform 7 concerts throughout the school year. Fifty-three (53) students from 14 schools participated in Honor Band, where they rehearsed together for 1 1/2 hours once a week for nine weeks each semester. Eleven (11) students from 5 schools participated in a Jazz Band pilot program. Students who participate in Honor Band and Jazz Band share what they learn with their peers in their own school bands through the leadership and musical maturity they gain. Three of Overture's employees were instructors for Honor Band and one employee for Jazz Band.
