During election season we made tens of thousands of non-partisan "get out the vote" calls to remind our community to vote. We also supported Asian Pacific Islander voters by printing translated voter guides and reaching them in language. We activated our members to take action around policies that matter to them most.

JADE DISTRICT. This year our Jade District location based program really began to take off. We put together a diverse and representative steering committee for the district, voted to install district banners, and held numerous community visioning events to create a plan for district development. These were done in Chinese, Spanish, Russian, English and Vietnamese.

LEADERSHIP DEVELOPMENT & ORGANIZING. Our Asian Pacific Islander Community Leadership Institute continued to develop new leadership for API communities through a formal program setting. We organized around numerous issues, including expanded drivers cards.
