182 adults (16 and older and not enrolled in public school) received direct instruction to enable them to function on the job, within their families, and in society. 42 students completed their high school equivalency diploma. 16 graduates entered postsecondary education or training. 5 students entered employment and 22 retained employment.

Explanation of grants: 24 students received scholarships for the cost of the High school equivalency exam ranging in amount from \$14 to \$65 per person and totaling \$1,116. Payments were made directly to the test vendors and testing centers so the funds could not be used for any other purpose.

English Language/Civics instruction for 12 adults seeking to speak English better and to become participants in the community or to gain citizenship.
