THE YWCA EARLY CARE AND LEARNING CENTER IN ROCK SPRINGS PROVIDES QUALITY, DEPENDABLE CHILDCARE TO AN AVERAGE OF ONE HUNDRED CHILDREN PER DAY FROM BIRTH TO AGE TEN. THE ORIGINAL CENTER OPENED IN 1977. IN 2009, A SEPARATE INFANT AND TODDLER CENTER WAS BUILT. CHILDREN LEARN FROM A DEVELOPMENTALLY APPROPRIATE CURRICULUM WHILE PARENTS ARE ABLE TO WORK OR GO TO SCHOOL. THE CENTERS FOCUS ON SCHOOL READINESS AND AGE-APPROPRIATE EXPERIENCES TO PREPARE THE CHILDREN FOR THEIR FUTURE. THE YWCA PROVIDES FINANCIAL ASSISTANCE TO THOSE PARENTS WHOSE INCOME QUALIFIES AND WOULD NOT OTHERWISE BE ABLE TO AFFORD QUALITY CHILDCARE. THE YWCA HOSTS A SUMMER DAY CAMP FOR SCHOOL-AGED CHILDREN. OVER THE DURATION OF THE SUMMER, APPROXIMATELY THIRTY CHILDREN ATTENDED THE PROGRAM ALLOWING PARENTS TO CONTINUE WORKING OR ATTENDING SCHOOL,

THE YWCA SUPPORT AND SAFE HOUSE (SASH) PROGRAM CONTINUES TO PROVIDE COMPREHENSIVE SERVICES TO DOMESTIC VIOLENCE, SEXUAL ASSAULT, AND STALKING VICTIMS, AS IT HAS FOR OVER THIRTY YEARS. THE PROGRAM HAS TWO OFFICES, ONE LOCATED IN ROCK SPRINGS AND ONE IN GREEN RIVER, AND A SAFE HOUSE THAT PROVIDES SAFE TEMPORARY SHELTER FOR VICTIMS IN NEED OF SAFETY. THE PROGRAM PROVIDES A CRISIS LINE THAT IS AVAILABLE TO VICTIMS OF THESE CRIMES IN SWEETWATER COUNTY TWENTY-FOUR HOURS A DAY THAT SPANS OVER TEN THOUSAND SQUARE MILES. VOLUNTEER AND STAFF ADVOCATES PROVIDE CRISIS INTERVENTION AND SUPPORT TO CALLERS. ADVOCATES TAKE CRISIS CALLS BY PHONE OR MAY RESPOND TO THE HOSPITAL, LAW ENFORCEMENT AGENCIES, OR OTHER COUNTY AGENCIES TO PROVIDE IMMEDIATE SERVICES. ADVOCATES ALSO RESPOND TO CALLS FROM LOCAL LAW ENFORCEMENT

BIG BROTHERS BIG SISTERS (BBBS) DEVELOPS AND MAINTAINS LONG-TERM MENTORING FRIENDSHIPS. WE FIND TWO PEOPLE, AN ADULT AND A YOUNG PERSON, WHO HAVE SIMILAR INTERESTS OR PERSONALITIES AND INTRODUCE THEM TO EACH OTHER. THE ADULT HAS BEEN CHOSEN BASED ON AN INTEREST IN HELPING THAT YOUNG PERSON BECOME ALL THEY COULD BE AND A DESIRE TO SUPPORT THAT YOUNG PERSON THROUGH THE UPS AND DOWNS OF DAY-TO-DAY LIFE. THE YOUTH IS SOMEONE WHO, FOR A VARIETY OF REASONS, IS IN NEED OF ADDITIONAL ADULT SUPPORT IN HIS OR HER LIFE. THE TWO COMMIT TO HELPING TO BUILD THIS FRIENDSHIP WITH EACH OTHER AND WITH THE SUPPORT OF BBBS STAFF. EACH AGREES TO SPEND REGULAR AMOUNTS OF TIME TOGETHER. WHAT THEY DO IS LESS IMPORTANT THAN THAT THEY ARE DOING IT TOGETHER. IN 2013-14, THE BBBS PROGRAM HAD FOURTEEN MATCHES AND TWENTY-FIVE UNMATCHED CHILDREN.
