IN FY12, THE COMMITTEE OBTAINED AND REVIEWED A WRITTEN REPORT FROM TOWERS WATSON, A COMPENSATION SPECIALIST FIRM, AND ASSIMILATED THE COMPENSATION DATA WITH RESPECT TO SENIOR MANAGEMENT-LEVEL COMPENSATION POLICIES FOR ORGANIZATIONS COMPARABLE TO THE FILING ORGANIZATION IN SIZE, GEOGRAPHIC LOCATION, NATIONAL PRESENCE, INDUSTRY AND OTHER RELEVANT FACTORS. THIS WRITTEN REPORT IS OBTAINED ONCE EVERY FOUR YEARS. SUCH COMPARATIVE DATA WAS SHARED WITH AND DISCUSSED BY THE BOARD OF DIRECTORS. THE COMMITTEE WILL DOCUMENT EACH YEAR THE BASIS FOR THE COMMITTEE'S RECOMMENDATIONS AND CONCLUSIONS FOR THE BENEFIT OF THE BOARD OF DIRECTORS. THE COMMITTEE SHALL KEEP A WRITTEN RECORD OF ITS ACTIVITIES AND SUBMIT A REPORT OF ITS ACTIVITIES TO THE BOARD OF DIRECTORS IN SUCH MANNER AND AT SUCH TIMES AS THE COMMITTEE OR THE BOARD DEEM APPROPRIATE, BUT AT LEAST ONCE ANNUALLY.
