The First Contact Street Outreach Program provides crucial support to homeless, runaway and at risk youth, up to age 21, via street-based outreach and a centrally located drop-in center Services include access to basic needs such as food, clothing, hygiene items, camping gear, showers and laundry, case management supporting areas such as education, employment, housing and health (including pre/post natal support) and counseling services The program served 423 unduplicated youth in FY2014 Youth Shelters Counseling Center provides free counseling by Masters level licensed therapists to families with youth under the age of 22 The Center utilizes a strengths-based positive youth development approach to helping families identify effective solutions to challenges that are often precursors to youth homelessness and runaway behavior, including drug and alcohol abuse, school truancy, youth gang involvement, teen pregnancy, etc The program served 141 unduplicated individuals in FY2014 Youth Shelters Workforce Education Initiative teaches youth valuable life skills through hands-on activities such as improving job readiness, on site employment training, internships and community service Youth Shelters is an officially designated distance learning site for G E D preparation, testing and graduation through Santa Fe Community College The services listed in the initiatives are offered to all Youth Shelter clients, across programs Youth Shelters Civic Justice Corps provides educational advancement, restorative justice opportunities, and on-the-job training for 18-22 year olds recently involved in the Juvenile Justice System The program served 30 unduplicated individuals in FY2014 Youth Shelters Pregnant and Parenting Youth Initiative provides safety, stability and wellness for young families, including pregnant and parenting teens, through housing and other assistance Education is offered in areas such as nutrition, health, child development, domestic violence, and pregnancy prevention During FY2014 319 pregnant and parenting youth and 65 children received clothing, baby formula, referrals for pre-natal, post-natal, well-baby care and other critical services
