About Our Organization

Emerge! Center Against Domestic Abuse gives people the tools to build safer lives for themselves and their children. For nearly four decades Emerge! -- previously as Brewster Center and Tucson Centers for Women and Children -- has been working to ensure that community members struggling with abuse find long-term solutions for themselves and their children, and that our community is aware of domestic violence and its impact. Today, Emerge! is the largest exclusive provider of domestic abuse services in Southern Arizona

The mission of Emerge! is to provide the opportunity to create, sustain and celebrate a life free from abuse. We work with those who are among the most vulnerable to serious injury or death in our community, helping them to be safe and supported. We respond to the immediate crisis, and then assist them to heal from the trauma to create a better life for themselves and their children. Emerge! assists anyone who is impacted by intimate partner abuse, regardless of age, gender, income, spoken language, or other factors; the vast majority of the people we serve are women and their children.

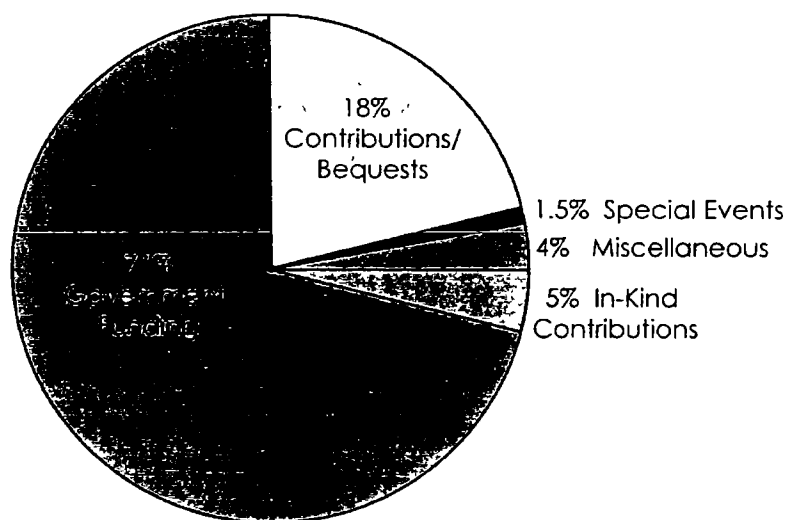
It takes a village of goodwill to end intimate partner abuse. Through the combined support of our many donors and partners, during the last year (July 2013-June 2014) Emerge! accomplished the following:

- **Emerge!'s crisis hotline received more than 5,000 calls** and provided emotional support, education, referral, and safety planning to callers.
- **Emerge! helped 4,584 people through our shelter and other locations for those who need services but not shelter.** Of those we served 3,984 were adults and 600 were children; 97% of the adults were women. People took action to address their abusive situation by:
 - calling our hotline,
 - coming to our shelter,
 - participating in programs that help them establish safe homes of their own, or
 - seeking help at one of our community based programs for those needing services like trauma recovery or case management but not shelter.
- **Over 1,600 people in our community increased their understanding about domestic violence and how to respond safely** by taking part in Emerge! community presentations.
- **546 child survivors of abuse learned new ways of responding to conflict, trauma and/or abuse** by participating in family services at Emerge!

- **Emerge! helped people to survive and recover from abuse** by providing:

- Shelter to 525 people
- Transitional and permanent housing support to 64 families
- Case management assistance to 2,438 people
- Crisis intervention counseling to 2,249 people
- Lay legal services to 973 people
- Life skills education to 1,162 people
- Safety planning support to 2,953 people
- Peer support groups for 595 people
- Transportation to critical services to 355 people

With the support of community individuals, corporate sponsors, family foundations and government agencies, Emerge! provides emergency and transitional services so people can address the crisis in their lives. Our innovative services included emergency shelter, a 24-hour hotline, safety planning assistance, case management, housing support, trauma recovery support for both adults and children, and lay legal assistance. Emerge! has the flexibility to address the wide-ranging and often complex issues faced by participants, such as dental treatment for an abuse survivor who had been struck in the face; a hotel stay for an abused man needing emergency shelter; security deposits for a family moving into a new home; equipment for an immigrant survivor to start a home-based business as a means of self-support; and many other vital services that may mean the difference between returning to an abusive situation or forging a life of self-sufficiency.



Our valued volunteers play a critical role at Emerge!. Volunteers serve as hotline responders, shelter workers, child advocates, community educators, and administrative support. During the past year, more than 150 volunteers contributed 4,700 hours of service which, when valued at \$12/hour, is a contribution equivalent to \$56,400. Volunteers are recruited from the community through Volunteer Southern Arizona, our *Emerge!* website, e-newsletters, and announcements at community events. In addition, many college interns in our community are able to get experience at *Emerge!* through our partnerships with numerous higher education institutions.
