United Food Bank is an community-based private nonprofit that provides hunger relief/food assistance by collecting, acquiring, storing and distributing food and related commodities through a network of partner social services agencies in our service area eastern Maricopa County, Gila & Pinal Counties and southern Apache & Navajo Counties. Our mission is to end hunger in Arizona by providing access to nutritious food through community partnerships, food distribution and education.

United Food Bank is resource driven as well as need driven. Thus, we provide as many resources as we are able to acquire through our best efforts, recognizing that there will be times when the need is greater than the available resources. We work to meet our mission by

- ❖ Providing food and related commodities and services to people in need through a network of partner agencies
- ❖ Providing a system for the distribution of food and related commodities
- ❖ Partnering with emergency food programs and other non-profit organizations that meet the critical needs of low-income hungry and food insecure families & individuals
- ❖ Educating the public about hunger and food insecurity
- ❖ Providing our services with compassion and respect for the dignity of the client

Highlights for Fiscal Year 2013-2014

Food Distribution

- We distributed 22,328,747 lbs of food and grocery items (21,977,399 lbs to 186 Community Partner Agencies/Sites & shared 351,348 lbs with 4 sister food banks)
- Total Distributed food provided more than 18,314,499 meals – over 50,177 meals daily (365 days/year)
- 72% (15,718,130 lbs) of all the food we distributed through partner agencies/sites went to 150 partners in the East Valley & Maricopa County
- During the year through our “Mobile Pantries” we made 1,336 distributions (an average of 111 distributions monthly) providing fresh produce and other food assisting more than 216,754 people
