Southwest Catholic Health Network (SCHN) provides medical coverage, under various contracts with the Arizona Health Care Cost Containment System (AHCCCS), for the state's indigent population. SCHN provides medical coverage for the Acute members eligible under Title XIX Medicaid program and Title XXI program, institutional care and home and community based services for the Long Term Care members, and medical coverage for the eligible members of the Division of Developmentally Disabled. SCHN operates a Medicare Advantage Plan under the Centers for Medicare and Medicaid Services (CMS), offering medical and prescription drug benefits to qualified members. It is operated as a Special Needs Plan for members who are eligible for both Medicare and Medicaid coverage.

In 2013, Mercy Maricopa Integrated Care was formed to provide physical and behavioral health care services on an integrated basis to Medicaid eligible adults with serious mental illness, and to operate as the Regional Behavioral Health Authority (RBHA) to coordinate the delivery of health care services to eligible persons in Maricopa County. Mercy Maricopa Integrated Care was awarded a three year contract plus two optional one-year extensions, effective April 1, 2014.

Mercy Maricopa Integrated Care is a consolidated entity of SCHN
