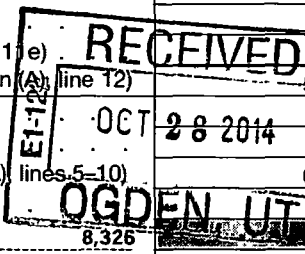

STEP UP is a charter school under Arizona Statute 15-101ET Seq with the tax exempt purpose of fulfilling state educational requirements. The ADM (average daily membership) decreased from 1191 students in grades K-8 to 58.6 in grades K-6.

STEP UP offered a free all day kindergarten program servicing approximately 20 students for which half day funding was received.

4c (Code:) (Expenses \$ 25,000 including grants of \$) (Revenue \$ 3,076)
STEP UP SCHOOLS offered an extended day and summer school program. This program extended the school day by up to 2 hours for students to stay on a voluntary basis, and was additionally carried out for 4 weeks during the summer for 4 hours per day.
