Annual Report
July 1, 2013-June 30, 2014

This year SaddleBrooke Community Outreach (SBCO) continued to enjoy the new Kids' Closet. Backpacks were distributed to schools in our service area for the start of the year, and were filled with school supplies geared to 3 different age levels. Jog suits and dresses were eliminated because they were not worn to school. Our policy has been to provide suitable outfits for classroom attendance.

The closet supplied wardrobes to 3075 students. Expenses for the closet for this fiscal year were
\$312,088.53

which includes depreciation on the building. Buyers were advised that vendors may need to add sales tax to purchases of clothing.

Teen Closet, our program for high school students in Pima County, took place in July with an additional shopping trip in January. Volunteers worked with 32 teens in July to purchase school-appropriate clothes at Target and Ross For Less. Eligibility is based on recommendations from school counselors, and participants must maintain passing grades, have good school attendance, meet with counselors regularly, and provide community service. Mimi Sander is the director of this program. An additional 22 students were part of the January shopping trip.

Expenses for Teen Closet = \$5125.45

Enrichment programs primarily took place in July and included College for Kids in Araviapa, swimming lessons in San Manuel, support of Triangle Y summer camp in Oracle, an Oracle School summer program and a reading program in Kearny.

Expenses for enrichment programs = \$27,500.00

College scholarships were used by recipients attending U of A, ASU, Pima Community College and CAC, Lipscomb, the Air Force Academy, NAU, So Plains College, Rice University and Cottey College. The first 2 years a scholarship has a value of \$1500 per year, and the next 2 years it is \$1,000 per year.

Expenses for scholarships = \$51,066.27

We tutor youngsters in 3 elementary schools, one junior high, and 2 high schools. Modest expenses for supplies were

Expenses = \$540.16

And we support U of A tutors in the Amphi School system in our service area. Those costs were
\$10,000.00

The 17th annual Walkathon in October had 319 registrants. A breakfast buffet was well received, and a number of items were raffled off to participants. Registration fee included a special T-shirt and breakfast. Marcia Van Ommeran was the Grand Marshal for all her support of SBCO in a variety of capacities.

Income = \$17,210.00

Expenses = 6,590.40

Students and staff from Mammoth/San Manuel were in attendance as well as many dogs, and one cat.

Our spring fund raiser was a Garden Train Tour with 6 homes that had train layouts in their backyards. We raised
\$1,067.69

November was the time for Thanksgiving food baskets. People donated many canned items, making it possible to devote money to the purchase of turkeys, rolls, pies and fresh fruit. Thirty complete baskets were delivered to the Oracle Ridge Elementary school and the health clinic in Oracle. Cash donations were strong enough to purchase the necessary items, and still give \$737.61 to Tri Community Food Bank.

Expenses = \$1000.00

Adopt A Family, headed by Ken & Ellen Perkins, distributed Christmas gifts to 286 children on the San Carlos Apache Indian Reservation, and to 111 families in the Tri-Community area. This program involves giving names and gift information to interested "adopters" and has no expense to SBCO.

The Cloth A Child donation program was renamed to Make A Difference. By the end of this fiscal year we had received \$55,131.25.

In March we hosted the annual food drive in SaddleBrooke, with all nonperishable items being delivered to Tri-Community Food Bank. An estimated 19,500 pounds were collected, along with more than \$12,000. Headed by Joan and Rich Roberts, more than 150 volunteers worked on this project, delivering flyers to announce the event, collecting curbside donations in all units, sorting at MountainView Country Club parking lot, loading trucks, driving to the food bank, and unloading. SaddleBrooke Ranch collected food from 52% of the community!

Food drive expenses = \$529.92

Installation of new officers took place at the April General Membership Meeting. Joan Coyne, Rick Cato and Mary Kay Stein were the volunteers of the year, and Long Realty was selected as supporter of the year.

Throughout the year we made quarterly financial donations to the Tri-Community Food Bank, to enable them to purchase needed items not supplied by the parent food bank.

Expense = \$31,973.00

We continued to email the monthly bulletins to SBCO members, and mailed 2 newsletters to all residents in SaddleBrooke. Publicity expenses include awards and website cost as well as the newsletters.

Publicity Expenses = \$10,685.00

Membership was 234 by the first of June. There were several small receptions held for new members to ask questions in a social setting. The number of reported volunteer hours was 18,028 (the equivalent of a bit more than \$400,000.00 at minimum wage!) and the recorded miles driven were 55,801.30.

Income = \$6334.00

Expenses = \$185.69

The Golden Goose Thrift Shop continued to be a strong retail operation. This 501c3 organization is dedicated to providing funds to us, and to Impact on So. AZ. While our receipts were noteworthy, we anticipate a bit of a decline because the GGTS will be adding space to their current building.

SBCO Income = \$610,000.00

The golf ball recycling program remained in effect, although Jim Handrigan asked the men's golf groups to assist him.

Golf ball sales brought in \$11,440.00.

Tucson Iron and Metal continues to provide an aluminum recycling bin in SaddleBrooke with proceeds coming to our programs.

Aluminum recycling gave us \$1734.50.

Grants were received from Schmidt Foundation, Sundt, Community Foundation of So AZ
\$8500 00

We continued to offer the Basha's Community Service Program A gift card is purchased through SBCO for \$5, and comes with \$5 on it The card owner may add any amount at any time, through cash or credit card transactions Every time the card is used for a purchase from the Arizona supermarket, SBCO receives 6% of that sale

Income from the cards \$4520 50

Jim Click Automotive Team included us in an annual raffle of a new Jeep Cherokee Tickets cost \$25 each, or 5 for \$100 SBCO retains all the money from the ticket sales The drawing will take place in the fall At the end of our fiscal year we had received \$1,875 00 in sales

It was a very successful year, raising more funds than budgeted, and spending less than anticipated We continue to be 100% volunteer, offering programs to youngsters in a 100 mile service area that includes 3 counties, and remains a very high poverty section of Arizona

The Los Angeles Times reported that children in the Southwest are especially vulnerable to hunger, with Arizona ranking 3rd for childhood hunger Rural areas have the most difficult time due to transportation problems in accessing food program sites

By clothing the children and getting them into schools with lunch programs we are working to keep these kids fed, educated, and on their way to productive lives
