CLIENT SERVICES: CARE SERVICES ENSURE THAT PEOPLE LIVING WITH HIV/AIDS HAVE ACCESS TO THE SERVICES THEY NEED TO MAINTAIN OPTIMAL HEALTH AND LIVE AS INDEPENDENTLY AND SAFELY AS POSSIBLE. OF ALL THE PEOPLE SERVED LAST YEAR, 97% WERE LOW INCOME, WITH 55% LIVING BELOW THE POVERTY LEVEL.
