The Foundation awarded 1575 tuition aid awards totaling \$5,257,111, to primarily low income and working poor families for the 2013-2014 school year.

A consistent analysis is completed on all applications by a third party with the parameters of the Bureau of Labor Statistics being used. If analysis shows a need after the parameters are applied, a award is made. The grants are then approved by the Foundation Board, and a check is sent in the name of the school so that it can be applied to the students tuition balance. The families application, analysis, verification of student status, and check copies are maintained by the Foundation.
