



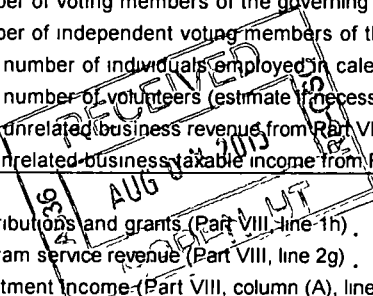

UMC Grant Funds Monitoring with Regards to UMC Foundation

In an effort to streamline the financial process while keeping the separation and integrity of both University Medical Center (UMC) and the UMC Foundation, the following procedures and protocol have been established to handle financial tracking. The following is a framework between the UMC Foundation (Foundation) and the Fiscal Services Department of UMC (Fiscal Services).

Financial Operations

- Fiscal Services, through the direction of the Controller, will assign an appropriate team member to maintain the financial records for grant funds. This shall be done separately from the financial records of UMC general funds.
- Grant donations will be made payable to UMC Foundation Inc. and held for reimbursement of expenses.
- All financial records for the grants will be maintained in the current system of SAP utilized by UMC.
- Departments will provide to Fiscal Services all external documents related to financial reporting.
- Financial reporting will be provided along with any communication and copies of invoices to request reimbursement from UMC Foundation for grant funds.
- All use of the Foundation Tax ID will remain with Foundation and prior approval by the designated voting Foundation Board of Directors member must be granted before it is used for any transaction (event, grant, donation backup, etc.)

Grants

- The donations received directly to Fiscal Services shall be deposited into the Foundation's operating account, unless a separate fund reflecting the purpose of the donation has already been established. At the end of every month, Fiscal Services shall prepare a list of donations received in that month. The list will include, among other things:
 1. The name and address of the grantor;
 2. A description of the grant;
 3. The amount of the grant;
 4. The date of the grant;
 5. The specific purpose or fund designated, if any.
- Appropriate documentation of donations (i.e., receipt for cash, copy of check, merchant copy of credit card, etc.) will be maintained by Fiscal Services.

Disbursements

- All disbursements remain in the control of the Foundation. No member of UMC Finance Division or Fiscal Services will have disbursement or check signing authority.

- Foundation disbursement checks will, at all times, remain in a secured area of Fiscal Services.
- Request for Disbursements (RFD) will come from UMC Fiscal Service department and be accompanied by supporting documentation, Including but not limited to, invoices.
- The RFD form will list the date of the request, the amount of the request, the payee, the purpose of the disbursement and the account from which the disbursement is being made. The RFD will also show the net balance in the accounts from which the disbursements are being made (after deduction of the requested disbursements).
- No disbursements may be made, and no Foundation checks may be signed, until the RFD form has been signed by one or more Foundation board members according to the following protocol:
 - An RFD containing requests none of which individually exceeds \$5,000 may be authorized by the Treasurer of the Foundation.
 - An RFD in which one or more of the individual requests exceeds \$5,000 must be authorized by both the Treasurer and the President of the Foundation board. In the event that the same individual holds the title of both President and Treasurer, the Secretary of the Board shall act as the second signatory.
- All expenditures of approved good and services purchased through UMC will require an invoice to outline the final cost of such goods and services. The invoice, together with minutes of the Board meeting in which the purchase was approved, will be attached as an exhibit to the RFD.
- Once an RFD has been approved with appropriate, supporting documentation, Fiscal Services will prepare the disbursement checks for signature.
- The board of the Foundation shall approve a resolution whereby UMC's Director of Community Affairs (or the officer acting in a similar capacity with respect to the Foundation) shall be authorized as a signatory on UMC accounts. Such officer's signature may be affixed only to those checks or other disbursements that have been authorized by a validly executed RFD.
