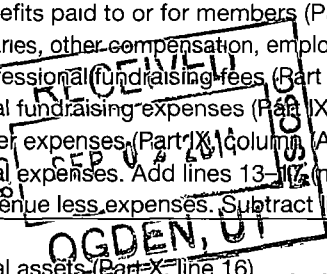

Musicians are selected by audition to participate in a "stair-step" training program that currently consists of six ensembles (String Orchestra, Symphonic Winds, Chamber Winds, Symphonette Orchestra, Percussion Ensemble and Youth Symphony Orchestra).

Young Musicians Competition ("YMC") - PYS sponsors an annual musical competition that is open to all non-professional music students who reside in and attend school in grades 6 through 12 in the State of Arizona. Winners of the Senior Division of YMC are awarded scholarships to national music camps and the two top winners perform concertos in concert with Phoenix's professional orchestra, The Phoenix Symphony. Winners of the Junior Division are awarded cash prizes.

4c (Code: _____) (Expenses \$ 21,432 including grants of \$ 21,344) (Revenue \$ 23,414)
Music Memory - This service is a cultural enrichment program designed to enhance the understanding and appreciation of symphonic music. It is designed primarily for elementary school children in grades 3-6 and is open to all schools in the Greater Phoenix area. Each year, the musical pieces to be studied are selected by the PYS Youth Symphony Orchestra Director and the PYS program committee prepares a listening guide that is provided to the classroom teacher for study prior to the performance of a concert by the PYS Youth Symphony Orchestra that features the selected music.


