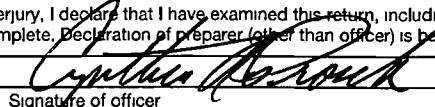

community forums that RJCA achieves its primary objectives of effectively addressing livability crime which helps prevent further crime and community deterioration while repairing the harm caused by criminal behavior. RJCA also provides opportunities for community-building by creating relationships within neighborhoods allowing people to work together to reinforce norms of acceptable behavior. As referred participants (offenders) recognize the impact of their behavior, they receive support and often times connect with the community in positive ways. In FY14, 303 adult offenders enrolled in RJCA out of 350 referrals (87% enrollment rate), 291 cases were conferenced out of 298 (98% attendance rate), and 248 successfully completed the program out of 269 closed cases (92% success rate). Referred participants completed 2,684 hours of community service, gave 176 apologies, and donated \$1,875 and 22 in-kind donations in the communities that were affected. They also completed 376 hours of self development activities such as working on education (GED) or writing reflection essays. Over 238 community member participations and 128 trained volunteer facilitations occurred by over 120 volunteers and 2 direct victims who met face-to-face with the 291 conferenced cases.

offenders enrolled in RJCA out of 97 referrals (82% enrollment rate), 80 cases were conferenced out of 88 (91% attendance rate), and 79 successfully completed the program out of 83 closed cases (95% success rate). Referred participants completed 551 hours of community service, gave 77 apologies, and donated \$100 and 6 in-kind donations in the communities that were affected. They also completed 221 self development activities such as working with a tutor, creating a graduation plan, attending anger management classes or writing reflection essays. Over 148 community member participants, 38 trained volunteer facilitations occurred in the 80 cases conferenced. Along with the referred youth, 2 direct victims, 80 family members and 2 non family supporters met face-to-face with community members at the conferences.
