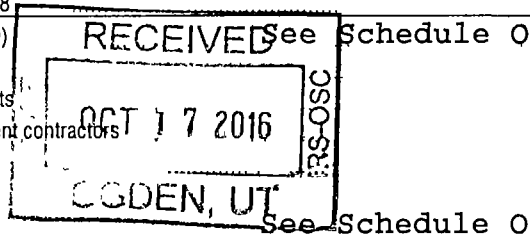

The organization, did not, during the year, pay any premiums, directly, or indirectly, on a personal benefit contract.
