The Food Bank is open Tuesday and Thursday for distribution of food and supplies. The Emergency Assistance program provides a variety of services, including emergency shelter voucher for homeless families, telephone and mail services to homeless individuals. The Emergency Assistance also provides referral services as necessary.
