Using multiple proven therapeutic approaches, IFD provided in-home family counseling services and life skills services to 1879 families having children at risk of placement into state custody. In delivering these services, IFD used \$252,380 in government pass through funds and private donation funds to alleviate basic family needs for food, shelter and clothing as well as assisting with school related needs.
