THE PRIMARY FOCUS OF THE YAKIMA ROTARY TRUST DURING THE 2013-14 FISCAL YEAR WAS RESEARCH FOR A NEW LARGE COMMUNITY BASED PROJECT TO BENEFIT THE YAKIMA VALLEY A PROJECT TO DEMOLISH AND RE-BUILD THE YAKIMA FOOD BANK WAS APPROVED THE OLDEST FOOD BANK IN OUR COMMUNITY, THE YAKIMA FOOD BANK HAS BEEN DOING ITS WORK FOR 40 PLUS YEARS WITHOUT MUCH FANFARE RUN STRICTLY BY VOLUNTEERS, THEY DISTRIBUTED 591,928 POUNDS OF NUTRITIOUS FOOD IN 2013 TO OVER 89,000 INDIVIDUALS THEIR CURRENT BUILDING HAS BEEN PATCHED AND MAINTAINED THROUGHOUT THE YEARS BUT WITH SAGGING FLOORS AND LEAKY ROOF IS NO LONGER VIABLE THE TRUST AGREED TO A FINANCIAL CONTRIBUTION OF 50% OF THE ESTIMATED COSTS UP TO \$182,500 PARTNERS IN THE PROJECT ARE THE CITY OF YAKIMA, YAKIMA ROTARY, YAKIMA SOUTHWEST ROTARY, YAKIMA VALLEY COMMUNITY FOUNDATION, UNITED WAY FOUNDATION, PACIFIC POWER FOUNDATION, YAKIMA FEDERAL SAVINGS AND LOAN, AND FRIENDS OF THE YAKIMA FOOD BANK ONCE COMPLETED IT WILL BE RENAMED THE YAKIMA ROTARY FOOD BANK THE LAST FINANCIAL CONTRIBUTIONS WERE COMPLETED FOR IMPROVEMENTS AT FRANKLIN PARK IN YAKIMA, WASHINGTON THAT INCLUDED THE CONSTRUCTION OF A ROTARY PAVILION, PLAYGROUND ADJACENT TO THE PAVILION, AND TWO PICNIC SHELTERS THE PROJECT WAS A PARTNERSHIP WITH THE CITY OF YAKIMA PARKS AND RECREATION AND THE THREE LOCAL ROTARY CLUBS (YAKIMA ROTARY, YAKIMA SOUTHWEST ROTARY AND YAKIMA SUNRISE ROTARY)

THE TRUST IS ALSO ADMINISTERS A RENEWABLE SCHOLARSHIP ENTITLED THE MARY MONROE DAVIS SCHOLARSHIP PROGRAM. THIS ANNUAL PROGRAM AWARDS SCHOLARSHIPS TO RESIDENTS OF YAKIMA COUNTY WHO PLAN TO CONTINUE THEIR EDUCATION IN UNDERGRADUATE STUDY. RENEWABLE SCHOLARSHIPS FOR TUITION AND FEES ARE OFFERED EACH YEAR FOR FULL-TIME STUDY AT AN ACCREDITED TWO OR FOUR-YEAR COLLEGE OR UNIVERSITY OF THE STUDENT'S CHOICE. DURING THE 2013-14 FISCAL YEAR, THE FIFTH YEAR OF THE PROGRAM, THE TRUST AWARDED 36 NEW SCHOLARSHIPS TOTALING \$238,500.
