NAMI Washington held teacher and facilitator trainings for its core education and support group programs Connection Peer Support Group, Family Support Group, Family-to-Family class, Peer-to-Peer class, Basics class, and In Our Own Voice. Staff and volunteers also fielded over 450 information and referral calls from individuals and families about treatment and support services in their local communities across Washington.

NAMI grassroots advocates and volunteers are active with their state legislators, informing them of positive developments in the mental health system and advocating for improvements that will lead to more positive mental health and health care outcomes. They also advocate with local mental health authorities, county commissioners, city leaders, law enforcement and others in local communities.
