 Academic Enrichment phase (AEP) - We successfully recruited our 13th Cohort of scholars this year, including students from Renton, Highline and Seattle School districts. Meanwhile, Cohort 11 completed the summer of 2013 with 98% earning placement into independent schools or highly-capable public school programs. Cohort 12 achieved a 100% placement rate in college preparatory settings with 43% in public school programs and 57% earning placement at independent schools

**4b** (Code ) (Expenses \$ 526,963 including grants of \$ 19,039 ) (Revenue \$ 600 )  
 Leadership Development (LD) - 116 scholars participated in leadership retreats with 85% demonstrating enhanced leadership skills and increased participation levels in leadership activities in school and community. To date we have successfully placed students in over 300 internships with 85%+ receiving high marks by workplace mentors. 100% of our high school seniors were accepted to four year colleges and universities. For the last five years over 50% of every cohort matriculated to the Most/More selective colleges and universities across the nation

 Academic Counseling and Support Services (ACSS) - 260 scholars received comprehensive support services in middle and high school through on-site school visits, mentorship and skill-building workshops. Focus on increasing skills for academic success included organization, time management, accountability, self-advocacy, collaborative learning and risk taking with 87% of 7-9th graders demonstrating proficiency in at least four skill areas. Summer learning opportunities included nearly 70 students participating in 21 different programs locally and nationally
