The Early Intervention program addresses the needs of children under age 3 who have developmental delays and who meet the state set criteria for early intervention services. Program services include developmental assessment and evaluations, occupational, physical and speech therapy, educational services and social work services through a Parent Coaching Model, family counseling services, resource coordination and parent education and support. Early Intervention also addresses the needs of children who are at serious risk of falling behind in their development and of not being successful in school. Services are provided to families residing in homeless shelters, on the Tulalip Reservation and through drop in play groups at local libraries. Funding for this program is provided through school district contracts, Snohomish County Early Intervention Program, county Child Development Services, public and private insurance, and grants and individual donations including United Way.

4b (Code:) (Expenses \$ 866,433 including grants of \$ 0) (Revenue \$ 0)

The Nurse Family Partnership program is an evidence based home visitation program serving first time parents 21 years and younger during their pregnancy until the child is two years old. Specially trained community health nurses visit the families in their home weekly and bi-weekly, supporting healthy parent and child outcomes and family self sufficiency. The program provides health assessments, referral and coordination amongst health care and community providers, pregnancy, parenting and childhood developmental education, engaging parent-child activities, promotes optimal social, emotional overall development and builds on client strengths to promote their education, employment and parenting opportunities. The NFP program served 188 families during the year.

The Parents As Teachers program is an evidence based home visiting model of services to pregnant and parenting mothers and fathers whose children are under five years of age. Funding for this program is provided through a combination of private grants and federal funds. PAT served 45 families during the year.
