**AMENDMENTS TO ARTICLES OF INCORPORATION
SOROPTIMIST INTERNATIONAL OF ANACORTES
(FORMERLY KNOWN AS SOROPTIMIST CLUB OF ANACORTES)**

ARTICLE I. NAME: SHALL BE AMENDED AS FOLLOWS

The name of the corporation shall be SOROPTIMIST INTERNATIONAL OF ANACORTES

ARTICLE III. POWERS AND PURPOSES SHALL BE AMENDED AS FOLLOWS

Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the promoting of the objects of the Soroptimist Federation of the Americas, Inc and applying them toward the betterment of local conditions, and the making of distributions to organizations that qualify as exempt organizations under section 501[c][3] of the Internal Revenue Code, or the corresponding section of any future federal tax code

ARTICLE IV. DEDICATION SHALL BE ADDED AS FOLLOWS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions for the furtherance of the purposes set forth in Article III hereof

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal tax under section 501[c][3] of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170[c][2] of the Internal Revenue Code, or the corresponding section of any future federal tax code





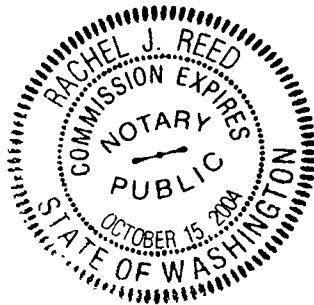
