990 Part III, Line 4d: A grant in the amount of \$29,050 was given to the University of Alaska Foundation for Alzheimer's research.

990 Part VI, Line 11b: A copy of Form 990 and all related schedules is e-mailed to all members of the board of directors prior to filing.

The form is reviewed and signed by the board treasurer.

990 Part VI, Line 12c: All members of the Board of Directors are given a copy of the conflict of interest policy annually. Each board member must sign the form stating that they have received a copy of the Conflict of Interest Policy and currently comply with the policy. The policy was last distributed in July of 2014.

990 Part VI, Line 15b: Review of performance and compensation is done annually for all employees and CEO. A performance review form including annual goals is used and committee minutes are kept to document deliberation and decisions regarding the CEO's review. Independent compensation data is used to determine salary ranges and annual compensation for each employee and CEO.

990 Part VI, Line 19: All documents are available upon request. An Annual Report containing some financial information is also available on the organization's website and is mailed to donors.

990 Part XI, Line 9: Other changes in net assets or fund balances: Donated services and use of facilities totaling \$15,629 are not included in total revenue (line 1) or total expenses (line 2) and therefore do not need an adjustment on line 6 to reconcile net assets; line 9 reverses line 6. Also, a rounding difference of \$3 is included in line 9.
