Community Impact The challenges our communities face are complex and too big for any single organization to solve United Way of the Mid-Willamette Valley (United Way) works collaboratively throughout Marion, Polk, and Yamhill counties to identify community needs based on current data and to direct resources toward collaborative and individual programs that will result in the most successful, long-term outcomes United Way strives to improve lives by supporting community-wide initiatives that will help children, individuals and families to succeed The United Way believes a long-term commitment is essential in order to make a lasting impact Community impact funds are awarded on a two-year cycle through a competitive grant process The Community Impact Council The Council is a committee of community volunteers representing various sectors of the community Its role is to identify specific community-wide concerns, strategize for long-term outcomes, and gather current community data on Education, Financial Stability, and Health, and to leverage other resources to meet the needs of the tri-county service area in the Mid-Willamette Valley United Way has identified three priority focus areas Education, Financial Stability, and Health In addition, United Way provides funding to help cover Basic Needs Basic Needs services address the needs of families and individuals throughout Marion, Polk, and Yamhill Counties who are struggling or are in crisis, so that they can stabilize their lives and move toward self-sufficiency Funding is directed to agencies that are at the frontlines of helping local families and individuals (below 250% Federal Poverty Level) meet Basic Needs During the fiscal year ended June 30, 2014, United Way funded twenty-five unique programs and the 211 info initiative Impact funds have been allocated to projects that demonstrate measurable outcomes During this fiscal year, 90,000 or one out of five people in Marion, Polk and Yamhill county individuals were served through United Way support
