Early literacy programs reach babies and young children, especially those vulnerable to low literacy, during a crucial window for early brain development Targeting families with limited resources and reading ability, these programs help parents by encouraging them to become the first, best, and most permanent teachers of their children Last year, 31,000 young children and parents benefitted from an educational outreach literacy program that motivates them to read together at home throughout the year More than 440 caregivers, educators and home health providers were able to rely on the program to enhance their work with struggling families The New Parent Program reached more than 8,700 babies and parents, encouraging parents to read with newborns and engage with the library
