1	Briefly describe the organization's mission or most significant activities COMPASS FAMILY SERVICES ("COMPASS") BEGAN IN 1914 AS TRAVELERS AID SAN FRANCISCO, ESTABLISHED TO HELP NEWCOMERS TO SAN FRANCISCO WHO WERE LOST AND IN NEED OF ASSISTANCE. LAST YEAR WE CELEBRATED 100 YEARS OF SERVICE TO THE COMMUNITY. OVER THE CENTURY, AS CLIENT NEEDS HAVE CHANGED, COMPASS HAS CHANGED WITH THEM. BEGINNING IN THE LATE 1980S, THE AGENCY BEGAN FOCUSING ON SERVING HOMELESS FAMILIES WITH CHILDREN WHEN MORE AND MORE FAMILIES BEGAN APPEARING ON SAN FRANCISCO STREETS LACKING SHELTER AND OTHER BASIC NECESSITIES. COMPASS' MISSION IS TO HELP HOMELESS FAMILIES AND FAMILIES AT IMMEDIATE RISK FOR HOMELESSNESS ACHIEVE HOUSING STABILITY, FAMILY WELLBEING AND SELF-SUFFICIENCY. LAST YEAR WE SERVED MORE THAN 5,000 PARENTS AND CHILDREN WITH OUR CONTINUUM OF SERVICES DESIGNED TO RESPOND TO IMMEDIATE NEEDS, WHILE ALSO PROVIDING THE TOOLS FAMILIES NEED TO BREAK THE CYCLES OF HOMELESSNESS AND POVERTY.
