


Serving the educational and emotional needs of 271 students, grades Kindergarten through Eighth Grade, with a comprehensive and award-winning curriculum and philosophy. The School year lasts over 176 days and students matriculate into the most sought after High Schools. The school is open each day from 7:30 am until at least 6 pm. Therefore, 10.5 hours per day (conservatively), over 176 days, suggests that the school provides 2024 hours of continuous service each year. If one multiplies this through the student body number (2024 X 271), Black Pine Circle is providing 548,504 hours of education each year to our students and families. By maintaining a healthy financial aid program, the school retained nearly all students from the prior year. And the school has successfully retained its nationally recognized faculty.
