Outpatient Counseling Services - Napa and Solano Counties:

Aldea's outpatient counseling program helps children and families improve their mental wellbeing and strengthen their relationships. The program provides a wide range of therapeutic and psychiatric services at its outpatient clinics, in homes, and at schools and community-based organizations. In FY 2013-14, Aldea provided outpatient counseling services for 514 children and their families; 91 percent of clients improved their mental health.

4b (Code _____) (Expenses \$ 2,080,359. including grants of \$ _____) (Revenue \$ _____)

Treatment Foster Care - Napa, Solano, and Contra Costa Counties:

Aldea Treatment Foster Care and Adoption Services gives children the opportunity to thrive in safe, stable permanent homes by providing emergency placement, treatment and intensive treatment foster care and adoption services-including placement, case management, therapy and support-for children removed from their birth families due to abuse, neglect or emotional disturbance. Aldea also recruits, certifies, trains and supports foster and prospective adoptive parents. In FY 2013-14, Aldea provided treatment foster care and adoption services for 395 youth, and 88 percent of them improved their mental health.

4c (Code _____) (Expenses \$ 958,804. including grants of \$ _____) (Revenue \$ _____)

Supported Living Services (SLS) - Napa County:

Aldea Supported Living Services empowers adults with developmental disabilities to live independently in their own homes and to participate in the community. The program offers case management, personal assistance with life skills and employment, support groups, and recreational activities. In FY 2013-14, 44 individuals participated in Supported Living Services. All clients made progress on their treatment goals and 77 percent improved their interpersonal skills.
