Our programs currently touch the lives of more than 20,000 people each year. From its inception, Children's Council has been the hub of the local care landscape, working in partnership with the government funders, other community-based organizations, and child care providers to make affordable, high quality care a reality throughout San Francisco's diverse communities.

Family and Children's Services - Fiscal Year 13/14During FY 2013/2014, each month Children's Council administered payments to childcare providers on behalf of an average of 3158 children and their families. Additionally, Children's Council administered the central eligibility database for subsidized child care and early education and helped almost 1,000 children enroll in subsidized child care centers.

Fiscal Intermediary - Fiscal Year 13/14 Children's Council was the Fiscal Intermediary for the Preschool for All program. Additionally, we are the fiscal intermediaries for three non-profits including the Child Care Planning Council (CPAC), the San Francisco Child Care Provider Association (SFCCPA), and the Family Child Care Association of San Francisco(FCCASF).

Provider Services - Fiscal Year 13/14Children's Council's Provider Support Services team conducted 77 workshops and other educational opportunities, which had 929 provider participants, in English, Spanish, and Cantonese. Children's Council worked with 190 family child care Centers (FCCs) as part of our Family Child Care Quality Network, matching individual consultants who provided technical and other assistance to raise the quality of child care and education of those FCCs. Children's Council's Health and Nutrition Department supported 285 child care providers throughout San Francisco and San Mateo counties through the USDA Child Care Food Program, providing financial reimbursement for serving nutritious meals to children in their care. During that time, 1,171,000 healthy meals and snacks were served to the almost 2,500 children in their care. 30 child care providers took the Healthy Apple Award self-assessment, which provides information, training, and resources for child care providers to improve the nutrition and physical activity practices in their child care environments and received technical assistance training from staff at Children's Council and SF Dept. of Public Health. 160 hours of training were provided through our CLASS Plus training program, which included additional and on-site coaching to 14 (unduplicated) ECE providers. Additionally, 83 (unduplicated) ECE providers completed the CARES Plus program, including online training on CLASS and professional development advising.

R&R - Fiscal Year 13/14Through a comprehensive resource and referral service conducted on-line, on the phone, and in person, Children's Council provided 11,048 referrals to child care, helped 5,000 families connect to child care financial assistance. Additionally, Children's Council assisted 100 families with children with special needs find inclusive child care that met the needs of their child.
