Wu Yee's Child Development program supports young children to reach their potential by offering full-day and year-round high-quality subsidized child care services to children aged 0-5. Our target population is low-income and recent immigrant families who are working in job training or in school and need child care. The program is designed to provide comprehensive child care services, to integrate parent involvement, education, physical health, mental health, nutrition, special needs and social services to the families that Wu Yee serves.

Wu Yee served 224 children in six child development centers located throughout the city of San Francisco; 26 children through the FCC

Wu Yee's Child Care Subsidies Program assists eligible low-income families in San Francisco with child care case management, referrals and payments to child care providers. This is an essential program allowing parents to work or attend vocational trainings while their children are enrolled in a high quality child care program. Wu Yee's Child Care Subsidies Program issued \$3,847,258 million in child care cost reimbursements to 625 children through the City Fund program.

Wu Yee's Child Care Provider Services Department provides training, technical assistance and stipends for child care providers in San Francisco in the various stages of their careers as well as improving quality through the Family Child Care Quality Network (FCCQN). Wu Yee's Provider Training programs partners with established child care providers by training them on latest child development topics, so that they can maintain and achieve high quality practices in their field. The department also supports child care providers who are new to the child care field by assisting them through the application process of opening their own child care business and by providing them with child development trainings. The program also conducts site visits to child
