Alternative Payment Programs: Are intended to serve two primary purposes: (1) enable low-income families to work and (2) improve low-income children's cognitive and educational development. The Alternative Payment Program determines which families are eligible for a payment assistance voucher. Once a family is determined to be eligible for a voucher, Case Manager's work with the family to connect them to child care. The Alternative Payment Program then reimburses the child care provider directly for the hours of eligible care used by the family.

Child Care Resource and Referral Program: Assists parents by helping them understand the full range of child care and school readiness options available to them, providing free child care referrals and information on choosing quality child care. Child Signature Program - Expense \$94,084: works with preschool programs to enhance the quality of care and education that children receive. The program addresses 3 general areas; Instructional strategies and teacher-child interactions, social-emotional development, parent involvement and support. Studies conclude that high quality preschool programs improve school readiness and lead to better long-term academic achievement. Active Bodies/Children and Weight Coalition of Napa County - Expense \$58,639.44: The Active Bodies program offers on-site and off-site coaching and professional development to 7 child care centers and 3 family child care homes with the goal of increasing the amount and quality of physical activity offered, and improving nutrition practices and policies. Active Bodies uses the Let's Move! Child Care assessment tools and program to assess facilities, then assists them in setting and working toward goals based on the assessment. Modeling of new physical activity ideas is done directly with the children 4 times throughout the year and professional development workshops are given to child care professionals 4 times throughout the year. 57 child care professionals and 356 children received services in 2013-14. The Active Bodies program is funded by a grant from First 5 Napa County.

The Children and Weight Coalition of Napa County is a coalition of professionals whose mission is to provide leadership for the community and serve as a resource for the development of interdisciplinary, evidence-based strategies to promote children's health through sound nutrition and physical activity. In 2013-14, the coalition continued it's commitment to educating the community to Rethink Your Drink: a campaign to increase water consumption while reducing the consumption of sugary beverages. A series of 4 parent nutrition classes were also offered to families needing guidance in feeding young children. The Children and Weight Coalition of Napa County is funded with the Active Bodies program by First 5 Napa County.

California Child Care Initiative Project - Expense \$40,829: Focuses on the recruitment and retention of family child care providers, with a focus on those willing to offer care for infants or during non-traditional hours. 26 family child care providers benefitted from the service.
