FVLC's Legal Department is recognized throughout the community as the leader in providing top quality legal services to people fleeing domestic violence. This year, FVLC provided legal information, assessments, paperwork preparation assistance, advice and council and representation to more than 700 legal clients.

4b (Code:) (Expenses \$ 535,132. including grants of \$) (Revenue \$ 370.)

The Family Intervention Unit responded to more than 4,000 police reports, and provided crisis intervention and case management to more than 2,400 clients, the majority of these clients resided in Oakland. FVLC's Mobile Response Team served domestic violence survivors in Alameda County by providing 24 hour crisis counseling, safety planning, temporary hotel relocation, transportation, advocacy and other services.

The Youth Department facilitated the presentation of Safe Dates, a teen dating violence curriculum, to more than 1,000 students from Oakland middle schools in partnership with the Alameda County Public Health Department as part of Dating Matters, a Centers for Disease Control national initiative. FVLC also began the development of a youth leadership program designed to prevent teen dating violence in Oakland.
