Business Development and Incubation services. During the fiscal year 2013-2014, El Pjaro CDC assisted 31 Small Business owners in preparing loan packages or to access other types of financial resources to start or expand their businesses. Alternative sources included family investment, owner investment, and community lenders. Of the clients assisted three have received over \$129,000.00 in capital infusion from banks and other lenders. Many client loans are still in progress at the close of the fiscal year. Because many of our clients have difficulties accessing loans, we are continually looking for alternative sources of financing. Early in 2014, El Pjaro CDC became a trustee for Kiva Zip. This program provides 0% interest loans up to \$5,000 for small businesses and entrepreneurs who are financially excluded and underserved. These loans are crowd-funded by individual lenders on the Kiva Zip website, connecting entrepreneurs with dozens of lenders who can be potential brand ambassadors and customers to their business. El Pajaro CDCs newest program, The Commercial Kitchen Incubator (CKI) officially began in early autumn 2013. The start of the kitchen was delayed by several months. As a way to introduce the CKI and our clients to the community, El Pjaro CDC has had three open house events and participated in Watsonvilles Holiday Factory Sale with approximately 80 community members attending. Currently, 20 clients are producing in the kitchen, several of these are seasonal users, three have used the kitchen and moved elsewhere, and three are in the process of becoming kitchen users. Clients face several stumbling blocks in the process not the least of which is financing for their business venture. Acquiring county and state licensing has proven a challenge for others. Through the experiences of our clients, we are learning and becoming more able to assist and streamline processes for future clients.
