Briefly describe the organization's mission

Low Income Investment Fund ("LIIF") is dedicated to creating pathways of opportunity for low income people and communities. LIIF's overarching mission is poverty alleviation. LIIF achieves this mission by investing capital for healthy communities and families. LIIF builds bridges between private capital markets and places where low income people live. LIIF partners with low income communities, community based organizations, funders, and financial institutions to create a network of support to address the challenges facing low income individuals and families. Since its founding in 1984, LIIF has provided \$1.5 billion in financing and technical assistance for projects benefiting low income communities, leveraging investments of \$7.5 billion. Through these projects, we have served over 1.7 million people and supported 62,000 Units of Housing, 243,000 Child Care Spaces, 72,000 Spaces in Schools for Children, and 16 Million Square Feet of Community Facilities. LIIF is headquartered in San Francisco.
