Hexcel Corporation, recognizing its responsibility as a corporate citizen, strives to improve the quality of community life in the areas in which the company operates. It is the company's belief that shareholders, employees and business in general benefit by this commitment to the community well being and that it will serve Hexcel's long-term objective of consistent profitable growth.

ANNUAL CONTRIBUTION

Corporate contributions will be funded through the Hexcel Foundation, a non-profit subsidiary of Hexcel Corporation. The corporate contributions budget will be a dollar amount equal to a percentage of the company's expected net earnings before taxes, based upon its proposed profit plan for the year. The percentage will be reviewed and approved annually by the company's executive management serving in their capacity as trustees of Hexcel Foundation.

OBJECTIVE

1. The corporate responsibility will be as objective and equitable as possible to all organizations seeking charitable funding.
2. The program will be concentrated in communities in which Hexcel operates, involving as many company locations as possible in support programs.
3. Company contributions will include personal participation as well as dollars. Employees will be encouraged to give time and talent to community projects and organizations of their choice.
4. Special consideration will be given to organizations in which there is a high degree of involvement or interest by Hexcel employees.
5. The company will also consider in-kind (or non-cash) contributions such as the use of company facilities or the donation of services, in addition to direct financial support.

PROCEDURES

1. The overall responsibility and authority for the contributions program will reside with executive management, serving in their capacity as Trustees of the Hexcel Foundation, which will approve all contribution policies and formulate and allocate the program's fiscal budget.

2. Annually, the Foundation administration will prepare a company-wide contributions budget for the ensuing year and obtain the necessary approvals. A contingency fund of up to 10 percent of the approved corporate budget will also be established to handle unexpected requests for corporate funding.
3. All major contributions (those totaling \$1,000 or more) originating from operations management, will be approved by the Hexcel Foundation and charged either to the Foundation or the contribution expense account, as appropriate.
4. Each Hexcel location may also make additional, miscellaneous donations (those under \$1,000), which will be charged directly to the appropriate site account.

PRIORITIES

An organization applying for corporate support must be a publicly supported organization as described by the Internal Revenue Code in Section 501(c)(3) or other applicable section and demonstrate that contributions to it are deductible for income tax purposes. In addition, the Hexcel Foundation will give priority to the following four areas in deciding on contributions to be made:

1. Endeavors dedicated to science, engineering and technology — museums, science fairs and special events in key operating cities or those which are nationally significant.
2. Education — direct financial aid to higher education and scholarship funds. Special consideration will be given to those institutions offering degrees related to materials science and scholarships for students studying materials science.
3. Youth activities — groups promoting leadership skills and civic responsibility; job training; sports.
4. Civic and community improvement/cultural activities — local or regional civic and economic groups in support of the free enterprise system or betterment of the community including cultural and environmental activities; planning and urban development organizations.

All requests from federated campaigns (United Way, United Givers Fund, etc.) must meet the same criteria as other organizations. In determining its contributions, the Hexcel Foundation will consider the following criteria: the number of employees residing in the fund area, the needs of the community as indicated by the budget increase over prior years and the size of other local contributions. Caution will be taken when processing other requests to avoid duplication in support of organizations already supported by federated campaigns.

Hexcel will not support the following organizations through its contributions program:

1. Religious organizations.
2. Political parties, organizations, candidates, or issues.
3. Veterans, labor or other groups which affect only a small segment of the community.
4. Courtesy or journal advertising for religious, governmental, veterans, labor, or other groups which affect only a small segment of the community.
5. Organizations which function only in and for the benefit of communities where Hexcel has no operations or where no employees reside.
6. Individuals.
