The Asian & Pacific Islander American Health Forum (APIAHF) is a national advocacy organization to promote policy, program and research efforts for improving the health of Asian and Pacific Islanders in the United States and U.S. affiliated jurisdictions in the Pacific. APIAHF programs and projects are categorized as follows: 1. Affordable Care Act Program: APIAHF provides technical assistance and supports a learning community for community-based organizations that are engaged in outreach, education and enrollment assistance for expanded health insurance options provided by the Affordable Care Act. The program provides grants, tools, skills, and trainings and disseminates best practices and information for community-based organizations to optimize outreach, education and enrollment activities for Asian American, Native Hawaiian and Pacific Islander (AA and NHPI), Limited English Proficient (LEP) and immigrant consumers. The program also collaborates with national health policy organizations to advocate for improvements to health insurance marketplaces to increase accessibility for AA and NHPI, LEP and immigrant consumers. 2. Capacity Building Programs: APIAHF provides technical assistance, training and tools to community-based organizations to enhance their capacity to serve and advocate for their communities. It is designed to enhance the ability of community-based organizations to plan, deliver, monitor and evaluate effective, evidence-based prevention interventions and strategies. The program also works with community leaders to develop the internal infrastructure (e.g., finance, human resources, governance) to support these interventions and to build lasting organizations. 3. Community Engagement Services: APIAHF provides opportunities for community members, service providers, researchers and advocates to network and share their expertise and recommendations with each other and with policy makers to promote the health and well-being of Asian Americans, Native Hawaiians and Pacific Islanders. APIAHF disseminates promising practices, analyses, and information including data and research through conferences, conventions, and electronic media including APIAHF's website, social media, and publications. This allows network partners to utilize these resources for their own local and state-based work, while contributing to a body of knowledge and action that is organized by APIAHF at the national level. These programs also award grants and provide other resources to community members, service providers, researchers to promote the health and well-being of Asian Americans, Native Hawaiians, and Pacific Islanders. 4. Health Policy Development: APIAHF advocates for health equity in health services and all policies, for greater access to care and insurance coverage for all vulnerable populations, and for accurate representation of the health needs of distinct and diverse Asian American, Native Hawaiian and Pacific Islander communities, robust research and data development and responsive external relationship development. 5. Domestic Violence Program: The Asian & Pacific Islander Institute on Domestic Violence is a national resource center on domestic violence, sexual violence, trafficking, and other forms of gender-based violence in Asian and Pacific Islander communities. It serves a national network of advocates, community-based service programs, national and state organizations, legal, health, and mental health professionals, researchers, policy advocates, and activists from social justice organizations. It analyzes critical issues, promotes culturally relevant intervention and prevention, provides consultation, technical assistance and training, conducts and disseminates research, and informs public policy with the goals of strengthening advocacy, changing systems, and preventing gender violence through community transformation to fulfill its vision of gender democracy. APIAHF is the fiscal sponsor for the program effective June 1, 2012. The program incorporated under the name of Asian Pacific Institute on Gender-Based Violence in June 2013. It received the IRS 501(c)(3) exempt status in October 2013. The program commenced operations under the new corporation as of October 1, 2014. 6. Special Projects: APIAHF delivers conventions and conferences bringing together community-based partners, government officials, congressional leaders, and health advocates to highlight the health needs and disparity among the Asian American, Native Hawaiian and Pacific Islander communities.
