In fiscal year 2014 the Food Pantry distributed 461,213 pounds of emergency food supplies to over 13,845 families or 43,682 individuals. The food distributed is a combination of government commodities, purchased food and donated food from the Food Bank of Alaska, retail stores, individuals and religious organizations.**4b** (Code:) (Expenses \$ 116035 including grants of \$) (Revenue \$ 31698)**EMERGENCY HOUSING SERVICES -**LSSA operates two housing units that benefit individuals that would otherwise be homeless. Our Roosevelt House provides safe and affordable housing for low income individuals with long term behavioral health issues and other medical problems. In fiscal year 2014 the program served six full-time tenants.The Transitional Living Program (TLP) provides assistance and transitional housing for single homeless men. The goal of the program is to break the cycle of homelessness and help the residents find sustainable employment and thus sustainable housing. Clients are required to have a job or secure one in the first 30 days of occupancy and are required to be free of all substance abuse. Residents are also required to share in household chores as yard work. In fiscal year 2014 the program served 28 men.**4c** (Code:) (Expenses \$ 222553 including grants of \$) (Revenue \$ 179)**DIRECT ASSISTANCE -**LSSA's Direct Assistance Program covers three main areas. First is Neighbor to Neighbor, where we offer assistance to individuals who are looking for work or are newly employed. In 2014 we assisted 1,116 individuals with vouchers for bus passes, clothing, state ID's or drivers license, birth certificates or prescription care. Our second area is medical transportation where we assisted with 1,244 rides to and from medical appointments. The third area is assistance to stranded rural Alaskans who have found themselves stuck in Anchorage without transportation back to their rural village after being medevaced to Anchorage or having completed substance abuse treatment programs. We assisted 34 individuals with transportation home.**4d** Other program services (Describe in Schedule O.)
