28 During the last fiscal year, the Willamette Master Chorus, in addition to increasing our budget due to program growth, has changed its staffing to make up the contract with a local marketing firm Executive Director and Operational Management Services. In the 11 months since we have entered into this contract we have seen a 19% growth in our community donations with a 39% decrease with the costs associated with our donor and patrons, to include more timely and appropriate contribution recognition, the introduction of a monthly newsletter and a more streamlined approach to ticket ordering. We sold out six of our eight concerts causing us to move from a model of general admission seating to reserved seats.
