In the 2013-14 school year, the Berkeley High School Development Group received and processed over \$511,000 in donations and other revenue. Of this total, almost \$257,900 was unrestricted for general support of the Berkeley High School learning community. These unrestricted gifts funded direct student support through a school wide after school tutoring program, a college handbook for all juniors and seniors, a student organizer for each student, and First Step Scholarships for sixty-two college-bound graduates who were the first in their families to attend college. It also funded art equipment, student club support, field trips, and classroom supplies. Approximately \$253,500 was restricted to specific small schools, learning communities, and departments within Berkeley High School. As a service to the Berkeley High School community, BHSDG administers these funds at no cost. These funds provided student support in the form of tutors, writing coaches, and program coordinators, and also provided computers, musical instruments, college field trips, a college fair, science lab supplies and equipment, and professional training for teachers. BHSDG spent only \$28,293 on administrative and fundraising costs.
