New Ethiopia Reads library projects in Fiscal Year 2014 included the Gebeta community childrens library, which opened within the ER office compound, serving early grades children in the Kebena district of Addis Ababa The Organization also expanded and improved the library at the Ferzano Primary School in the Kembata-Tembaro region The Organization also continued the process of assessing and strengthening existing libraries both in Addis Ababa and the southern region around Awassa, added to library collections in both regions, continued services at the childrens community reading center in Awassa, and offered expanded classroom-and-library-based activities meant to mentor teachers and librarians in good reading instruction practice The Organization offered continuing professional development for librarians and teachers For the fifth year running, the Organization supported a professional development circle among school librarians in Addis Ababa In Fiscal Year 2014, the Organization invited these librarians into the process of writing and refining a rubric for assessment of school library programs This rubric will become part of the Organizations Book-Centered Learning training and advocacy program during Fiscal Year 2014 Fiscal Year 2014 saw two school openings in the villages of Azedebo and Fundame, villages not far from the city Durame These facilities are kindergarten and early-grade libraries, built and staffed by the Organization to serve existing primary school communities, and services more than 200 kindergarten children each Fiscal Year 2014 also saw the continuation of the Organizations deep rural mobile library outreach, called Horse-Powered Literacy, in the regions near Chancho in Oromiya and near Kololo in Kembata-Tembaro Volunteers continued to collect books and fundraise to send a container of English-language books to support the childrens library collections The Organization piloted a new project among athletes of Team Tesfa, a project called Women Athletes for Literacy and Learning, in which athletes were placed in school libraries to mentor children and be mentored by education professionals A great deal of time and work was put into reorganizing and improving organization structures both in the US and in Ethiopia
