Form 990, Part VI, Section B, Line 15b: Based on the annual budget it is determined whether

there are expected to be sufficient revenues to provide for staff salary increases. If

increases are indicated they are awarded based on each staff members annual performance

evaluation score. Key employees are handled in the same manner. Each May the CEO's job

performance is evaluated by the executive committee of the board. Based on that evaluation the

executive committee determines whether any increase in compensation should be recommended to

the full board. The full board then receives the matter for action

Form 990, Part VI, Section B, Line 12c: The Company's conflict of interest policy is intended
