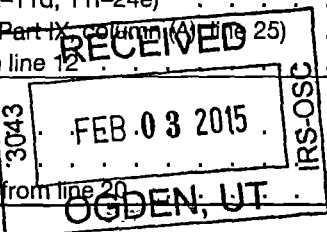

When typhoon Haiyan struck the Visayas region of the Philippines a relief effort was put in place as follows -

1) Restricted contributions (\$30,430) were collected from members and nonmembers and sent to YMCA of Cebu and IDEA (on Bohol) for immediate assistance (food and shelter) to the victims.

2) Restricted contributions from nonmembers (\$10,150) funded materials and supplies to make partial repairs to Maya Elementary School on Cebu. A group of 25 members and nonmembers (and groups from the Hirishima (20) and Seoul (10) YMCAs) paid their own expenses to participate in a work-camp on site

3) A restricted contribution of \$10,000 from a nonmember was used to repair and renovate the YMCA of Cebu.

4b (Code:) (Expenses \$ 15,197 including grants of \$) (Revenue \$)

A restricted contribution from a nonmember (\$15,000) funded materials and supplies to repair and renovate an elementary school near Chiang Mai in Thailand. A group of 33 members and nonmembers paid their own expenses to participate in a work-camp on site.

Provided funding for the production of a competition among school students to make videos that promote peace in its many forms. Provided monetary prizes to the winning schools. Also, recognized a community individual who exemplifies the attributes of a "peacemaker."

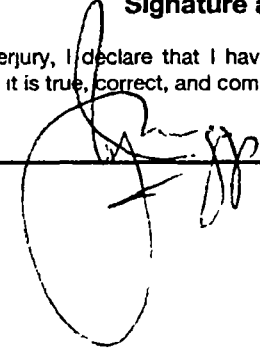
