>Part V, line 34, Changes to governing documents. The Organization amended its bylaws. The significant changes were increasing the number of allowable directors from 70 to 80, revising the Organization's policies on making gifts, decreasing the level at which a quorum is met for purposes of transacting business at board meetings from 50% to 40%, authorizing proxy voting on certain matters, and authorizing electronic voting on certain matters.

>Parts I, II, III, and Schedule A were amended to more properly account for contributions, program service revenue, inventory sales, expenses, inventory, program service accomplishments, and the organization's public support percentage. Schedule G was deleted as unnecessary.
