Organization's Primary Exempt Purpose:

VE Global (VE) fosters the development of children at social risk in Chile
to serve as positive role models, educators and advocates of social justice.
VE Global annually recruits, selects and trains between 20-30 volunteers
from around the world to provide volunteer support to children's homes,
community centers and other partner organizations located in Santiago, Chile.
Volunteers create and implement innovative educational and recreational
programming for children and youth at social risk. VE has 5 main projects:
1) Vamos a Leer: Summer motivational and educational reading program;
2) Liga de Deportes: Monthly health and wellness sports league;

- 3) Festival de Arte: Biannual art and performance exhibition and art workshops;
- 4) English in Motion: English language workshops during the academic year;
- 5) Original Volunteer Workshops: Volunteers plan and execute a variety of innovative, creative workshops with children and youth to support social and emotional learning and skill building.

VE Global volunteers work full-time in Chile for a minimum four month commitment, successfully integrating into VE partner organizations as extra human resources to support the children and youth. VE requires this considerable commitment to ensure that continued cycles of abandonment are broken, thus generating a positive net effect in the lives of the children that are supported by its programming.

Line 28, Expenses/Grants (\$50,322); Program Service Accomplishments

VE Global grants funds to VE Global Chile to support the selection, training and ongoing in-country support of international volunteers in Santiago, Chile. Selected volunteers commit to a minimum 4-month, full-time volunteer work experience. VE Global Chile provides roughly 35,000 to 40,000 hours of in-kind, donated volunteer labor to its partner organizations annually.

VE Global Chile partners with 4 residential group homes that support children that have been removed from their families by the Chilean justice system. In addition to these four residential children's homes, VE Global Chile also partners with a school for children with special needs and a community center located in a socially-vulnerable neighborhood of Santiago, Chile. Through their volunteer work and commitment, VE provides direct educational and recreational support to over 250 children in its network of Chilean partner organizations.
