Part VI Section A Line 5: In July of 2013 our board hired an Executive Director who was charged to run the retail store, manager the daily finances of the organization, manage volunteers, community relations and a variety of other leadership tasks. This position was created when the organization opened and we had 3 trustworthy and transparent Executive Director's before July of 2013. Acting outside of her employment responsibilities the previously mentioned Executive Director stopped paying sales tax and stopped filing all required tax returns. Shortly thereafter, she started signing unauthorized checks to herself from the organization. Furthermore, she used the organizations debit cards for both small and large personal purchases. She continued this behavior until she resigned in December of 2014.

The amount taken for the FY in question for this 990 form is \$18,796.

The board's response to this situation began with issuing the former Executive Director a demand letter with the list of monies taken and a request for explanation. Secondly, the board has taken the issue to the police and is pursuing restitution through the criminal court process.
