A major continuing objective of Community Advance is to provide programs that significantly advance the life-skills of students. We provide a mentoring program ("The Club") for Middle School students (6th-8th grade) attending nearly community public schools. A majority of students attending these schools are Hispanic or Black students, with a significant proportion underperforming in mathematics and reading, from single-parent families, have a high dropout rate, and essentially all are eligible for free or reduced priced lunches. The weekly after-school "Club" sessions throughout the school year include a life skills training topic (presented by invited community leaders), a Biblical focus topic to encourage character and moral values development, and participation in one of several structured elective activities. Student interaction with adult leadership in each of these activities is encouraged by staff and volunteer adult mentors. Planned occasions to interact with the parent(s)/guardian(s) of the students is a priority objective. The enrollment now exceeds 100 students. The Club curriculum has been expanded to span the 3 middle-school years, to include focus on career exploration. During the summer school recess, a six-week summer session ("The Summer Club") is also offered with half-day programs five days per week; enrollment now exceeds 130 students.

4b (Code:) (Expenses \$ 23,214 including grants of \$ -0-) (Revenue \$ -0-)
We recently established a computer learning center, initially equipped with 18 computers (including individual audio headsets). We plan to add additional units to provide a total of 24 computer stations. This facility initially is focused on providing The Club students with Internet access to facilitate the curriculum developed for career exploration. In addition, these students also use this facility in some of the student electives. We plan subsequently to utilize this facility for other Community Advance programs.

4c (Code:) (Expenses \$ -0- including grants of \$ -0-) (Revenue \$ -0-)
Community Advance has established an annual scholarship program providing two graduates of a local high school, Northwest Classen High School, funding for up to four years of approved college expenses (up to \$2,500 per academic year) while attending any accredited college or university in the State of Oklahoma. The first two awards were made in the Spring of 2014. Payments are to be made directly to the educational institution during each semester of attendance, so that no actual disbursements were processed in the Fiscal Year ending July 31, 2014. This scholarship program is underwritten by endowment funds contributed as a designated memorial.
