WE COMPLETED CONSTRUCTION OF SQUASH COURTS AT OUR FACILITY IN SUMMER OF 2014. THE MISSION OF THIS PROGRAM IS TO CHANGE THE TRAJECTORY OF DISADVANTAGED YOUTH RESIDING IN THE OVER-THE-RHINE COMMUNITY BY HELPING THEM REACH THEIR FULL ACADEMIC AND ATHLETIC POTENTIAL. URBAN SQUASH IS A NATIONALLY TESTED YOUTH DEVELOPMENT PROGRAM OVERSEEN BY THE NATIONAL URBAN SQUASH ASSOCIATION. THE PROGRAM COMBINES ACADEMICS, MENTORING, FITNESS, COMMUNITY SERVICE, CULTURAL ENRICHMENT, AND COLLEGE PLACEMENT FOR STUDENTS IN THE OVER-THE-RHINE COMMUNITY. IT IS AN INTENSIVE YEAR ROUND PROGRAMING THAT TAKES PLACE AFTER SCHOOL, ON THE WEEKENDS, AND IN THE SUMMER AND ENGAGES STUDENTS FROM THE TIME THEY JOIN IN ELEMENTARY SCHOOL OR MIDDLE SCHOOL UNTIL THE GRADUATE FROM COLLEGE. URBAN SQUASH AND TS EDUCATION PROGRAMS STRIVE TO HAVE A TRANSFORMATIVE IMPACT ON THE LIVES OF ITS PARTICIPANTS.
